Terms and conditions:

1. The upper age limit for JRFs/JPFs is 28 years as on the date of interview i.e. on 16/04/2018 (Relaxable by 5 years for SC/ST/Women/Physically Handicapped and OBC candidates).
2. Candidates should submit their bio-data in person while attending the interview from 9.00 AM to 10.00 AM. The registration process will be closed by the above specified time on the date of walk-in-interview.
3. The position is purely temporary and co-terminus with the project.
4. If at any time, in the opinion of the Director of the Institute you are found neglectful or unable to carry out research or guilty of conduct unbecoming of fellowship holder, the Director shall have the power to terminate your fellowship at any time without notice.
5. The position can also be terminated at any time by the Director without assigning any reason or earlier depending on the performance of the candidates.
6. Recruitment for the above temporary positions is governed by rules of the Indian Council of Forestry Research and Education and does not guarantee subsequent employment in any Institutes under the Council.
7. Candidates should bring original testimonials on date of birth, educational qualification and community certificate for verification. Attested copies of the same are to be attached with bio-data form while appearing for the interview. Candidates without Provisional Certificate/Degree Certificate awarded by the Universities will not be permitted to attend the interview.
8. The candidates called for interview will be paid travelling expenses equal to single second class train fare from the railway station nearest to his place of residence to the railway station nearest to his place of interview and back by the shortest route. If a place is connected by rail as well as by road or partly by rail or partly by road, the candidate will be entitled to get second class rail fare/actual bus fare whichever is less. The fare will be reimbursed only on production of tickets at the time of interview.
9. The number of posts of JRFs/JPFs and PAs may be changed as per the discretion of the Director.
10. Canvassing in any form will disqualify the candidate.
